Adventure Centre Terms & Conditions

At Alive Outside, we strive to put the safety of our staff and customers at the forefront of everything we do.

The activities your child will take part in while at the Adventure Centre have been rigorously assessed by our Health and Safety advisors, and procedures have been implemented to ensure the maximum safety of both the participants and the instructors.

Here is a summary of the policies we have in place to make the Alive Outside Adventure Centre as safe as possible.

1. BEFORE VISITING THE ADVENTURE CENTRE

Physical Condition of Child

Alive Outside recommends that any parent/guardian who has health-related concerns about their child taking part in activities speak with a healthcare professional beforehand. Everyone taking part in the Adventure Centre does so at their own risk.

2. AT THE ADVENTURE CENTRE

Adhere to Rules & Regulations

Each child will be fully briefed by Alive Outside staff on the rules and regulations for the activities they take part in. The child must then respect the instructor's requests and abide by their decisions, including when to wear safety equipment etc.

All activities are strictly supervised with staff who are trained, Garda-vetted and experienced in dealing with large groups of children. In the unlikely event of a child being unsafe to themselves or others, causing disruption to the group or being rude or difficult with staff, we reserve the right to remove this child from the activity without refund.

Water Safety

While all water safety precautions and lifeguard requirements will be adhered to, Alive Outside strongly recommends that everyone taking part in the Water activities is able to swim.

Photography/Image Rights

Alive Outside regularly has an official photographer at the Adventure Centre taking action photos and videos of participants in group settings - but never of individuals by themselves. These photos and videos may then be posted to Alive Outside's social media pages and used for promotional material, including websites, brochures, posters, advertising (print and online) etc.

By allowing your child visit the Adventure Centre, and by accepting these Terms & Conditions, you consent to photographs of your child - in a group setting - being used by Alive Outside.
